1. Grant of Rights & Artistic/Content Control

4. Release of Liability

I release and discharge Producer from all claims, demands, or causes of action that I may have by reason of anything contained in the recording, including but not limited to claims based on rights of publicity, privacy, defamation, or copyright infringement.

5. Hold Harmless & Indemnification

I agree to hold harmless and indemnify Producer, its affiliates, employees, contractors, and agents from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable attorneys' fees) arising from or related to:

Producer may use my name, image, likeness, voice, and biographical information in connection with the promotion, marketing, and distribution of the podcast episode in which I appear, without further permission or payment.

This agreement shall be governed by and construed under the laws of the state of California, without regard to conflict of law principles.
